Article 1 – Legal Provisions

Article 6 – Data Collection

Your data is collected by Van Vliet B.V. Personal data means: all information about an identified or identifiable natural person; an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier, or one or more factors specific to the physical, physiological, genetic, mental, economic, cultural, or social identity of that natural person. The personal data collected on the website is primarily used by the Controller for maintaining relationships with you and, where applicable, for processing your orders.

Article 7 – Your Rights Regarding Your Data

Under Article 13(2)(b) of the General Data Protection Regulation (GDPR), everyone has the right to access and rectify or erase their personal data or restrict the processing concerning them, as well as the right to object to the processing and the right to data portability. Any request should be accompanied by a copy of a valid identity document on which you have signed and indicating the address at which you can be contacted. You will receive a response to your request within 1 month of its submission. Depending on the complexity of the requests and the number of requests, this period may be extended by 2 months if necessary.

In the event of a violation of any law or regulation for which the visitor is suspected and for which the authorities require personal data collected by the Controller, these data will be provided to them following an explicit and reasoned request from those authorities, and as a result, these personal data will no longer be protected by the provisions of this privacy statement.
